Reference your application for grant of affiliation for BDS course to the College cited at the subject with an intake of 100 seats w.e.f. the academic session 2005-06.



2. The College shall abide by the statutes, ordinances, regulations and rules laid down by the Baba Farid University of Health Sciences from time to time.
3. The College shall fulfil all the conditions laid down by the Govt. of India/Dental Council of India/ Punjab Govt./University from time to time.
4. The College shall not make any admissions without obtaining permission of the Punjab Govt./University/Dental Council of India/Govt. of India.
5. The College shall pay First Affiliation Fee of Rs. 4,00,000/- before admissions are made.
6. The College shall pay Annual Administrative Expenses Fee of Rs. 2,00,000/- before admissions are made.
7. The College shall deposit a sum of Rs. 40 lac towards Endowment Fund in four equal annual instalments of Rs. 10 lac each in the form of FDRs for 5 years prepared jointly in the name of the Registrar, Baba Farid University of Health Sciences, Faridkot and the Chairman/President/Secretary of the Managing Committee of the College before making admissions.
8. The College shall be inspected every year by the University to ensure that the educational programme is being effectively and efficiently carried out and admissions can be allowed, till it is granted permanent affiliation. Thereafter,

periodical inspection shall be held after every three years. However, admissions shall be allowed only after notification in this behalf by the Punjab Govt. & the University.
